

SERVICE CONTRACT

The undersigned, _____ (owner), hereby makes application to Somewhere Farm, (Somewhere), for the service of one or more of its Clydesdale stallions, for my Clydesdale mare, at Somewhere Farm located at 1370 Tierra Del Sol Rd, Boulevard, CA 91905.

This service is engaged subject to the following terms and conditions:

1. NATURAL SERVICE: Somewhere agrees to breed Owner's mare to its Clydesdale stallion and Owner is to pay the accepted stud fee for this service, Somewhere agrees that should mare not attain pregnancy the mare may be rebred no later than the following season for no additional stud fee provided a satisfactory veterinary certificate is sent immediately.

2. Only mares which have been halter broken, will be accepted by Somewhere.

3. Owner's mare shall be a registered Clydesdale and be in a healthy state, and a veterinarian's certificate of health, dated not more than 30 days prior to delivery of the mare, shall accompany the mare when delivered. In addition to the requirement of a veterinarian's certificate of health, mare(s) shall be further examined by a veterinarian for abnormalities and/or diseases of the reproductive tract and thus declared in writing the mare(s) positive capabilities of conception. Known "problem breeders" will not be accepted.

4. Somewhere shall try diligently to settle Owner's mare. All breeding operations shall be administered solely by Somewhere's agents, employees, independent contractors, and/or subcontractors at Somewhere Farm and Somewhere has the exclusive right to determine the persons who shall participate therein.

5. After acceptance by Somewhere, the Owner's mare shall be released and turned back to the Owner at any time upon Owner's request.

Owner's mare, in all cases, shall be delivered at Somewhere Farm and shall be returned to Owner (or his/hers agent) at Somewhere Farm, and all transportation arrangements and charges shall be Owner's sole responsibility.

6. Owner shall pay to Somewhere the sum of \$12.50 per day for the care and feeding of each mare, in addition, Owner shall pay to Somewhere all veterinarian fees which Somewhere may incur (at its sole discretion) while Owner's mare is in Somewhere's custody and control. Owner's mare shall not be released to Owner from Somewhere Farm until all amounts due Somewhere hereunder have been paid in full.

7. Neither Somewhere Farm nor any of its agents, employees, independent contractors and/or subcontractors shall be responsible for injury to, or sickness or death of Owner's mare(s). Likewise, Owner shall not be responsible for injury to, or sickness, or death of any Clydesdale stallion of Somewhere Farm.

8. The date of acceptance of Owner's mare at the Somewhere Farm shall be mutually agreed upon by the parties prior to the delivery thereof.
